You acknowledge that from time to time our Site may be inaccessible or inoperable for any reason, including, without limitation: (i) equipment malfunctions; (ii) periodic maintenance procedures or repairs which RobbLAW may undertake from time to time; or (iii) causes beyond the control of RobbLAW or which are not reasonably foreseeable by RobbLAW.
